Minutes of Regular Board of Education Meeting held in the High School Library Monday, April 15, 2024 (7:00 PM)

Board of Education members present: Ms. Suzanne M. Mensch, Ms. Elizabeth T. Lanni-Hewitt, Ms. Joyce Donneson, Mr. George R. Kast, and Ms. Heather A. Wright.

The meeting was called to order by Ms. Suzanne M. Mensch, President at 7:01 p.m.

EDUCATIONAL PRESENTATIONS

The following presentations were given:

1. 2024-2025 Budget & Enrollment presentation - Dr. Carolyn Probst, Superintendent - Dr. Probst gave a detailed presentation on the budget and enrollment for the upcoming school year. She explained the challenges that the district is facing with increases in general insurance, employee retirement system contribution and health insurance rates, less state aid and declining enrollment. Dr. Probst stated that the allowable increase to the budget without going over the tax cap is 2.99%. She gave a detailed report on the declining enrollment and explained what reductions and additions are planned for the upcoming school year.

Comments on the budget presentation:

- 3 teachers spoke about the amount of teachers being excessed next year. They
 highlighted accomplishments of those teachers and described the loss of teachers
 through excessing and attrition. They asked the board to reconsider the decision to
 excess and explore other options to balance the budget.
- A teacher spoke about the teachers health care package in retirement and the retirement incentive in the teacher contract.
- A resident spoke about after school enrichment programs in the elementary school and suggested that they be offered during the school day without excessing teachers.
- A resident asked about the UPK program. She asked if it could be offered in house to both help students and perhaps bring revenue to the district.
- A resident spoke about local construction bringing multiple housing units and potential students to the district.

• A teacher asked what the plan is for the future as far as enrollment and staffing.
